## The road to 2024

As SACOME unveils a new strategic plan to guide it over the next five years, we reflect on the organisation's activities and its strong record of successful advocacy for our member companies.

During the COVID-19 pandemic, SACOME played a central role as the point of liaison and coordination between government and industry. Working closely with our member companies, we saw the South Australian resources sector continue to operate during a time where many sectors lay dormant. This demonstrated the sector's agility, resilience and importance to the state and national economies.

Over the last five years, SACOME has resolutely pursued a campaign of infrastructure investment. This led to greater investment in regional and remote infrastructure, the construction of the Joy Baluch Bridge, upgrade of the Strezlecki Track and other regional roads. Significant progress has also been made on the Northern Water Project, culminating in the proclamation of the Office of Northern Water Delivery.

SACOME has continuously advocated for measures that remove the long-standing hurdles to investment in South Australian resources projects – water, power and the path to market.

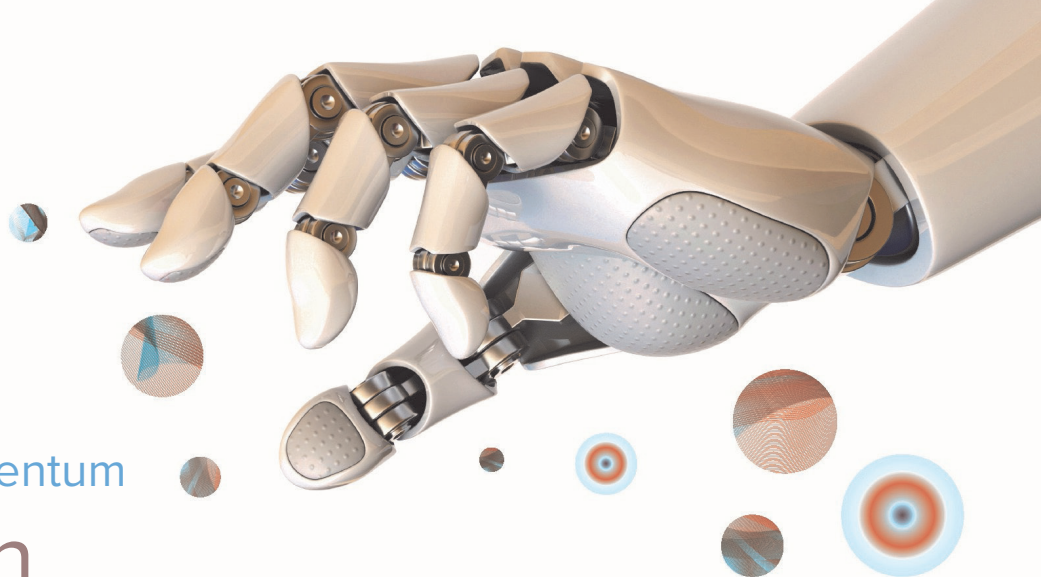
The Joint Electricity Purchase Group (JEPG) has proved to be a nation-leading instrument in shaping key pieces of legislation. This SACOME initiative has guided our sector in Mining Act review, Hydrogen & Renewable Energy Act development and review of the Energy Resources Act.

SACOME's second Economic Contribution Report in five years showed that 15 resource sector companies collectively contribute \$10.7 billion to South Australia's economy - the equivalent of 8.3% of GSP or \$1 in every \$12 in the State.

Promoting the value of the state's resources sector to our economic prosperity, SACOME has significantly increased its external campaigning.

From *Resources. But Not As You Know It* campaign to the *ResourcefulSA* community education campaign, and the STEM Digital Technology Program, SACOME is steadfastly committed to nurturing a pipeline of talent now for the workforce the sector will need in future.

Over the past 45 years, SACOME has grown alongside South Australia's resources sector, proudly advocating for and on behalf of the sector with true independence.
